**Old Business:**

- Sunday March 15<sup>th</sup> is the NYWA individual qualifier.

**New Business:**

Hotel rooms for Rochester:

- Block of rooms reserved at the Hilton in Rochester, MN.
- Historically the club paid 100% of coaches room fees and \$60 per night for all wrestlers (invite and qualified participants)
- **Change** to pay \$100 per night (individual K- 8<sup>th</sup> grade wrestlers: 2 nights) (Team wrestlers: 1 night)

NYWA youth team entry fee, \$150: Club unanimously agrees to pay fee if team qualifies.
